In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **36936** tCO₂e by 2027. This is a reduction of **30%**

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equate to **22,054** tCO₂e, a **32%**ge reduction against the 2020 baseline and the measures will be in effect when performing the contract.
